<u>DISTINGUISHING FEATURES OF THE CLASS:</u> This position involves responsibility for case coordination, counseling, and processing of claims for veterans and their dependents. The incumbent is responsible for exercising sound professional judgement and knowledge in the processing of claims, completing interviews and assessments to discern needs of the veteran, and making referrals for veterans as deemed necessary. The work is performed under the general supervision of the Director of Veterans Services. The incumbent performs related work as required.

**<u>MINIMUM QUALIFICATIONS:</u>** Candidates must meet the minimum qualifications at time of application. Either:

- (A) Possession of Bachelor's Degree; OR
- (B) Successful completion of sixty (60) credit hours **AND** two (2) years of human services experience; **OR**
- (C) Graduation from high school or possession of a high school equivalency diploma **AND** four (4) years of human services experience.
