TITLE: Senior Confidential Investigator
GRADE/SALARY: 32W - \$48,496 plus Excellent Benefits

THIS IS A NON-COMPETITIVE CIVIL SERVICE POSITION.

DISTINGUISHING FEATURES OF THE CLASS: These positions exist in the Offices of the District Attorney and Public Defender. This is specialized investigative work involving the investigation of alleged crimes, interviewing victims of alleged crimes and witnesses, and gathering evidence in connection with defense or prosecution of suspects. Unusual judgment is required in making decisions concerning the pursuance of investigative activities in relationship to such alleged crimes. The work is confidential and is performed under the direction of the District Attorney or Public Defender. Supervision may be exercised over Confidential Investigators. Incumbent performs related work as required.

MINIMUM QUALIFICATIONS: Candidates must meet the minimum qualifications at time of application.
Either:

- (A) Graduation from a regionally accredited or New York State registered college or university with a Bachelor's Degree in police justice, criminology or a closely related field **AND** two (2) years of experience in investigative work or law enforcement**; **OR**
- (B) Graduation from a regionally accredited or New York State registered college or university with an Associate's Degree in criminal justice or a closely related field **AND** four (4) years of experience as defined in (A) above; **OR**
- (C) Graduation from high school or possession of a high school equivalency diploma **AND** six (6) years of experience as defined in (A) above.

****Law Enforcement** – defined as “the enforcement of Federal, State or local laws governing society with the right to make arrests.”

NOTES:

- 1. Verifiable part-time experience as defined in (A) above will be pro-rated toward meeting full-time experience requirements.
- 2. Candidates **MUST** submit with application a copy of transcripts showing degree area and date degree conferred, if qualifying under (A) or (B) above.

SPECIAL REQUIREMENT: Possession of a valid New York State Driver's License at time of appointment. This license must be maintained throughout appointment.

SPECIAL QUALIFICATIONS/REQUIREMENTS for the Oneida County District Attorney's Office:

- 1. Candidates **must have** ten (10) more years of additional experience beyond the number of years of experience stated in (A), (B), and (C) above; **AND**
 - a. Must have issued no less than one-thousand (1000) uniformed traffic tickets; **OR**
 - b. Must have been the lead investigator on no less than twenty (20) “B” Felony level (NYS PENAL LAW, or equivalent State or Federal Law) investigations; **OR**
 - c. Must have been the lead investigator on no less than twenty (20) economic crime investigations; **OR**
 - d. Must have been the lead investigator on no less than two (2) homicide investigations.
